Part of the cost of brain health checks will be subsidized

A portion (20,000 yen) of the cost of a brain health check will be subsidized at designated medical institutions in the city. Those eligible will be sent a notice around the middle of May.

The period of subsidy for the brain health check is from August 1st, 2024 to January 31st, 2025.

People who meet all of those to whom all of the following (1 to 4) apply will be eligible to receive the subsidy:

- 1: Those enrolled in the city national health insurance as of April 1st, 2024;
- 2: Those who will turn 41, 44, 47, 50, 53, 56, 59, 62, 65, 68, 71 or 74 years of age during the 2024-25 financial year;
- 3: Those who are not in arrears with National Health Insurance payments;
- 4: Those who are insured with Higashihiroshima City National Health Insurance as of the date of the brain health check.

5-type mixed vaccine and 15-valent pediatric pneumococcus vaccine are now regular vaccinations

• 5種混合ワクチン・小児肺
・ 炎球菌15価の定期接種化

From April 2024, the 5-type mixed vaccine and the 15-valent pediatric pneumococcus vaccine have been added to the list of regular vaccinations.

If you wish your child to receive these vaccinations, you will need to take your Mother and Child Health Handbook and a preliminary examination form. Preliminary examination forms are available in the Medical Treatment and Health Division, the Children and Family Support Division, each branch office, and at medical institutions offering the vaccinations.

5-type mixed vaccine (diphtheria, whooping cough, tetanus, polio, hib)	From two months after birth to under 7 years and 6 months of age. Children who have completed vaccinations of the 4-type mixed vaccine and the hib vaccine cannot receive the 5-type mixed vaccine. In principle, those who have started vaccinations using both vaccines will be vaccinated with the same vaccines.
15-valent pediatric pneumococcus	From two months after birth to under 5 years of age. Depending on the child's age when the vaccinations were begun, the number of vaccinations (doses) will differ.

Please make a reservation directly to a medical institution in the city which offers the vaccinations. If you wish to receive the vaccination outside the city, there are formalities that need to be completed in advance.

Those fulfilling all of the following criteria are eligible to apply:

1. People who have an address in Higashihiroshima City, or whose place of work is in Higashihiroshima City.
2. People who are currently living with a relative, or intending to live with a relative (there are separate criteria for single people).
3. People whose income falls below a certain level (please enquire for details).
4. People who are not in arrears with municipal taxes.
5. People who are currently having trouble with housing.
6. People who are not members of criminal gangs.

Please note that it is not possible to keep pets in municipal apartments.

Applications will be accepted between Monday May 13th and Friday May 17th, at the Housing Division only (applications can also be posted). It is also possible to apply electronically. Application forms and details are available from the Housing Division (Jutaku-ka, 住宅課), or from branch offices and sub-branch offices, from Tuesday April 30th. Details of the amount of applications up until the previous day will be made public at the Housing Division and at each of the branch offices.

Applications for 'Iki-iki Kodomo Club' for the summer period

Iki-Iki Kodomo Clubs with spare capacity are now accepting applications for use of the service during the summer vacation. For details, please see the application form, available from May 7th from any of the clubs, from the Youth Development Division (Seishonen Ikusei-ka, 青少年育成課), from the branch offices of the City Office, or from the sub-branch offices of the City Office.

Applications can be accepted for children (grades 1-6 of elementary school) from households where all members of the household (aged between 18 and 70) work for at least four hours between 8:00 and 18:00, at least three weekdays (Mondays to Fridays) a week.

To apply, please take or send the application form to the Youth Development Division, or take it to one of the branch offices. The deadline for applications is 17:00 on Friday June 7th.

Applications must be received by this time.

If the club for your child's school is full, it is possible to use the club at a different school with places available (taking the child to the club and picking him/her up, and taking the child from his/her school to the club on days when it is necessary to go to school, is the responsibility of the parent/guardian).

Special system for National Pension Scheme payments by students

Those aged 20 or over are required to enroll in the National Pension Scheme. This is the case even for students. However, there is a special system for National Pension Scheme payments by students, under which the payments can be postponed if the individual's income is below a certain level.

Current students at educational facilities specified by the School Education Act whose income for the previous year is below a certain level are eligible to apply for postponements. These educational facilities include universities (graduate schools), colleges, high schools, specialist high schools, vocational schools, and other schools (the enrolled course being one year or more). The upper income limit for the previous year's income is 1,280,000 yen, plus 380,000 yen for each dependent family member, but this amount may differ if the student has dependent relatives, social insurance deductions, etc.

To apply, please use the application form, and include a copy of both sides of your student ID, and a Certificate of Enrollment (not a copy). If you have a My Number card, you can apply via the Myna Portal site. If you received an application form (a postcard) from the Japan Pension Service, please fill in the postcard with the necessary details and return it.

The period during which you were judged eligible for the special system of payments for students is included in the period for which you will be eligible to receive pension payments, but it is not included in the calculation of the pension amount you will receive in the future. If it is within ten years, you can make additional payments to retroactively pay the pension premiums for the period during which you were judged eligible for the special system of payments, and increase the amount of pension you will receive.

Certificates of tax payments for inspections of light vehicles

As a rule, certificates of tax payment are not required to be shown when three- or four-wheeled light vehicles undergo inspections.

If you need a certificate of tax payment, please refer to the following.

If you have paid using tax payment slips, you will have been sent a tax notice and certificate of tax payments at the beginning of May. Please use this document.

If you have paid using bank transfer, certificates of tax payment will no longer be sent from the 2024-25 financial year (except for two-wheeled vehicles). If you need a certificate of tax payment for your vehicle inspection, please request one in person or by post.

If you have paid using your smartphone, you will not be sent a certificate of tax payments. If you need a certificate of tax payment for your vehicle inspection, please request one in person or by post.

Please pay Light Vehicle and Motorcycle Tax by Friday May 31st.

A notice of non-payment (Tokusokujo, 督促状) will be sent to residents who have not paid their tax by the deadline. If you receive a Tokusokujo, please pay the tax immediately, using the payment slip enclosed.

※ **Note:** it takes about ten days for the Tax Collection Division to confirm payment of tax, and therefore you may receive a Tokusokujo even after you have completed payment. In this case, please ignore the letter.

Night-time and holiday hospitals

• **Night-time and holiday duty hospitals:** Full information about night-time and holiday duty hospitals within Higashihiroshima City is published in the Japanese-language version of the monthly city newsletter 'Higashihiroshima' (the page inside the back cover; only in Japanese), and on the Higashihiroshima City website (in Japanese and English). The information is subject to change at short notice, so before going to a medical facility, please be sure to call to confirm details.

Recently, there are more and more patients using emergency medical facilities at night and on holidays even though their situation is not serious. In some cases, these patients have prevented or delayed the treatment of patients with truly serious illnesses, and additionally, such cases are one of the reasons for doctors becoming overworked. Emergency medical facilities open at night and on holidays are for patients with serious, emergency conditions. Please try to visit the medical facility you use normally, during opening hours on weekdays.

• **Emergency medical treatment for children:** Please call the advice line on #8000 (if you cannot get through on this number, please call 082-505-1399). The service is available every day between 19:00 and 8:00 the following morning. You can obtain information about whether or not you should take your child to a medical facility outside of normal opening hours (at nights, on weekends or holidays, etc.).

• **If you have a medical problem at night or on weekends, and you are unsure about whether or not you should go to a medical facility:** Please call the Hiroshima area emergency consultation center on #7119. The service is free, and is available 24 hours a day, 365 days a year. The staff will be able to give you advice on whether to rest at home and see how symptoms develop, or whether you should go to a medical facility. If necessary, they can give you information about which facility to go to, or they can connect you directly to the 119 emergency service. In an emergency, do not hesitate to phone 119.

Please be aware that formalities relating to My Number Cards cannot be dealt with.
