Your tax payments support the city

- あなたの税金がまちを
- 支えています

Municipal taxes mainly include property tax, and individual and corporate inhabitant taxes. They account for 38.5% of the city's revenue (incoming money). The remaining 61.5% is subsidies from the national and prefectural governments, such as the local allocation tax and national and prefectural expenditure funds.

The municipal tax burden is approximately 210,000 yen per citizen (the amount of revenue from municipal tax divided by the number of citizens as of March 2025). Expenditures (money spent) for administrative services are approximately 520,000 yen per citizen. Your city tax is an important source of revenue. It is thanks to each citizen paying taxes on time that we are able to provide administrative services such as welfare, education, roads, disaster response, and waste disposal.

Higashihiroshima City has a population of 190,363 (as of March 31, 2025). The amount of general account expenditures is about 520,000 yen per citizen. From this, the following amounts are spent per person:

- Improvements to welfare, which includes nursery schools, support for the aged, etc.: approximately 196,000 yen;
- Repayment of city loans: approximately 47,000 yen;
- Improvements to the city, which includes repairs to roads, parks, etc.: approximately 58,000 yen;
- Improvements to education, which includes textbooks, desks, blackboards, etc.: approximately 64,000 yen;
- Garbage processing, which includes management of the garbage processing facilities, etc.: approximately 42,000 yen;
- Firefighting and disaster recovery, which includes recovery from damage caused by torrential rain, etc.: approximately 27,000 yen;
- Other, which includes support for working people: approximately 90,000 yen.

Please pay taxes before the deadline!

If you miss the deadline for payment of city taxes, you may be charged a late fee. Please cooperate to pay your city taxes on time.

The Tax Payment Information Center, located in the Tax Collection Division, calls those who have not paid their taxes to remind them to pay, reissues payment slips, and provides information about payment counseling services. If the center cannot reach you during the day, the staff may call you at night or on holidays.

Abolition of the Childcare Leave Withdrawal System

From April 1, 2026 onward, children enrolled in daycare will be able to continue attending daycare even if their parents take childcare leave, regardless of the child's age, if they wish to do so.

Children who left daycare due to parents' childcare leave before March 31, 2026 will also be able to re-enroll from April 2026 onward.

Please note that it is not possible to keep pets in municipal apartments, and that only those fulfilling certain criteria are eligible to apply.

Applications will be accepted between Monday November 10 and Friday November 14, at the Housing Division only (applications can also be posted). It is also possible to apply electronically. Application forms and details are available from the Housing Division (Jutaku-ka, 住宅課), or from branch offices and sub-branch offices, from Friday October 31. Details of the amount of applications up until the previous day will be made public at the Housing Division and at each of the branch offices and sub-branch offices.

Changes to parking fees for the City Office from December 1

Parking fees for nighttime, weekends, and holidays will change.

The new fees are as follows:

- 200 yen for 60 minutes (currently 100 yen for 60 minutes)
- Over 4 hours, up to 24 hours: 800 yen
- Over 24 hours: 200 yen for 60 minutes (maximum 800 yen per 24 hours)

Weekday rates during the opening hours for the City Office (8:00-18:00) remain unchanged.

Notifications of Medical Expenses which can be used for deductions

These will be sent to heads of households with members enrolled in National Health Insurance, and to members of the Latter-Stage Elderly Medical Insurance system.

Notifications covering medical visits from January-October will be sent in early February 2026, and those covering November and December will be sent in mid-March 2026.

If you wish to declare tax deductions for medical expenses, be sure to keep all receipts for November and December.

For expenses not listed in the notification, please confirm these with receipts.

From early February 2026, medical expense details will be available on Myna Portal.

National Pension Premiums are Fully Tax-Deductible

National Pension premiums paid between January 1 and December 31, 2025 (Reiwa 7) are eligible for social insurance premium deductions, including payments for past years, retroactive payments, and payments made on behalf of a spouse or family member.

In order to receive the social insurance premium deduction, it is necessary to attach documents proving that the premiums were paid when filing your year-end tax adjustment or income tax return.

For those who paid National Pension Insurance premiums between January and September 2025, a 'Social Insurance (National Pension Insurance Premium) Deduction Certificate' will be sent from the Japan Pension Service between late October and early November.

For those who paid National Pension Insurance premiums for the first time between October and December 2025, this certificate will be sent in early February 2026.

Please pay the National Health Insurance Premium (the fifth installment) by Monday December 1st. A notice of non-payment (Tokusokujo, 督促状) will be sent to residents who have not paid their tax by the deadline. If you receive a Tokusokujo, please pay the tax immediately, using the payment slip enclosed.

※ **Note:** it takes about ten days for the Tax Collection Division to confirm payment of tax, and therefore you may receive a Tokusokujo even after you have completed payment. In this case, please ignore the letter.

Night-time and holiday hospitals

• **Night-time and holiday duty hospitals:** Full information about night-time and holiday duty hospitals within Higashihiroshima City is published in the Japanese-language version of the monthly city newsletter 'Higashihiroshima' (the page inside the back cover; only in Japanese), and on the Higashihiroshima City website (in Japanese and English). The information is subject to change at short notice, so before going to a medical facility, please be sure to call to confirm details.

Recently, there are more and more patients using emergency medical facilities at night and on holidays even though their situation is not serious. In some cases, these patients have prevented or delayed the treatment of patients with truly serious illnesses, and additionally, such cases are one of the reasons for doctors becoming overworked. Emergency medical facilities open at night and on holidays are for patients with serious, emergency conditions. Please try to visit the medical facility you use normally, during opening hours on weekdays.

• **Emergency medical treatment for children:** Please call the advice line on #8000 (if you cannot get through on this number, please call 082-505-1399). The service is available every day between 19:00 and 8:00 the following morning. You can obtain information about whether or not you should take your child to a medical facility outside of normal opening hours (at nights, on weekends or holidays, etc.).

• **If you have a medical problem at night or on weekends, and you are unsure about whether or not you should go to a medical facility:** Please call the Hiroshima area emergency consultation center on #7119. The service is free, and is available 24 hours a day, 365 days a year. The staff will be able to give you advice on whether to rest at home and see how symptoms develop, or whether you should go to a medical facility. If necessary, they can give you information about which facility to go to, or they can connect you directly to the 119 emergency service. In an emergency, do not hesitate to phone 119.

**Citizens' Affairs Division: Out-of-hours opening**

The counters of the Citizens' Affairs Division are open until 19:00 on the first and third Thursdays of the month (except national holidays and the new year/year-end period). The dates for November are November 6 and November 20.

In addition, there is Sunday opening on November 9 and November 23, from 9:00 to 12:00. Wherever possible, please take someone with you who speaks Japanese. **Please note that divisions other than the Citizens' Affairs Division are not open at these times.** For details of what matters can be dealt with during these extended opening hours, and what you need to bring with you, please access the QR Code to the right to check the city website.

If you have a My Number Card, you can use it to obtain Certificates of Residence, etc., at convenience stores.

Please be aware that formalities relating to My Number Cards cannot be dealt with.
